Ladies and Gentlemen:

The Allegan County Equalization Department has prepared the attached report of values within the 24 townships and 9 cities in the county. The values as shown are extracted from the local governmental unit 2015 assessment rolls and have been equalized when necessary to compensate for any inequalities between jurisdictions as is required by Section 211.34 of the Michigan Compiled Laws. As determined through the audit process an equalization increase adjustment is being recommended for the industrial property class of Dorr Township.

The 2015 values as indicated by this report reflect a 4.64% increase in equalized value overall when compared to the 2014 values. The total county equalized value projected is **FIVE BILLION, FIVE HUNDRED FORTY-EIGHT MILLION, SIX HUNDRED SIXTY-EIGHT THOUSAND, TWO HUNDRED SIX DOLLARS (\$5,548,668,206)**.

I would like to commend the Equalization Department staff and each of the County's Assessing Officers for their dedication and hard work, without which, this report would not have been possible.



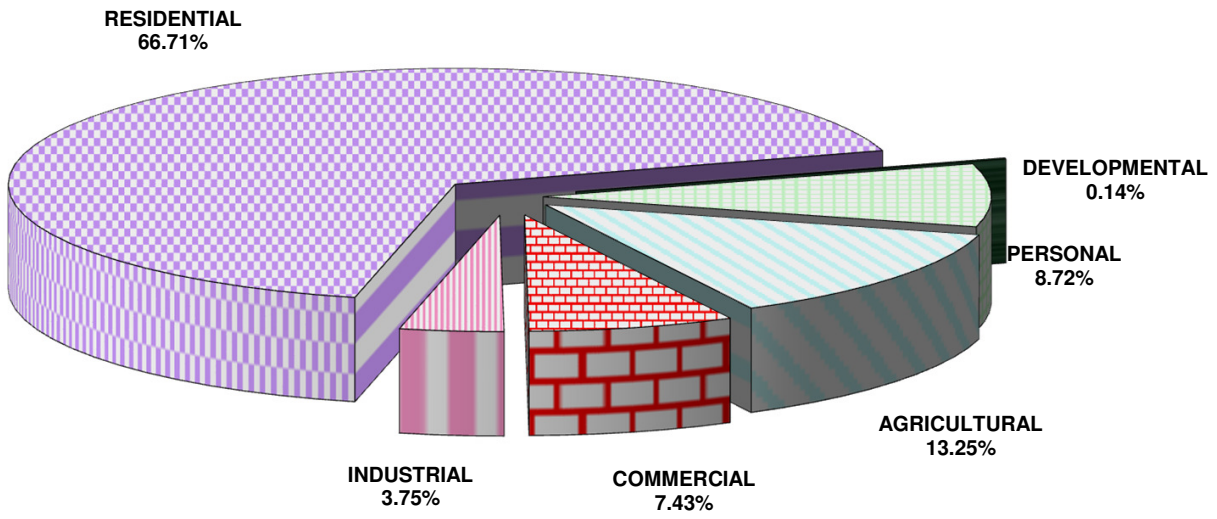
